One Act per Entry.

All contestants must perform with a horse - it doesn't matter how the horse is involved in the act.

The Judge's decision is final. No correspondence will be entered into.

No pre-recorded tracks of your own voice are allowed.

Please supply the backing tracks you wish to use.

The sound system & microphones will be supplied - please specify what equipment you require on your entry form.

Acts are limited to 6 minutes.

The number of entries may be limited due to time constraints.

No fireworks or pyrotechnics are allowed

No content that may offend *General Viewing* (ie no swearing) will be allowed.

It is the responsibility of the contestant to ensure all APRA requirements are met in relation to the use of pre recorded material.

The judges reserve the right to stop an act at their discretion before the end of that act.

The competition is open to:

- Those who have no contracts to record
- Must have produced less than 100 commercial (for sale) recordings.
- Do not earn a living from music or from live shows
